Religious Leader Indicted and Arrested for Coercion and Enticement of a Minor

03/25/2022 12:00 AM EDT SAN JUAN, Puerto Rico – A federal grand jury returned an indictment charging pastor Emmanuel Morales-Hernández, 29, of Lares, Puerto Rico, with coercion and enticement of a minor and attempted receipt of child exploitation material, announced W. Stephen Muldrow, U.S. Attorney for the District of Puerto Rico. The arrest follows an investigation by U.S. Immigration and Customs Enforcement’s (ICE) Homeland Security Investigations (HSI) with the assistance of the Puerto Rico Police Bureau (PRPB) and the U.S. Attorney’s Office for the District of Puerto Rico.

Sanford Foster Parent Indicted For Child Exploitation Offenses

Handberg announces today that a federal grand jury has returned an indictment charging Justin Dwayne Johnson, Sr. (47, Sanford) with 12 counts of production and attempted production of child sexual abuse images and videos and one count of possession of these materials. If convicted on all counts, Johnson faces a minimum mandatory penalty of 15 years, and up 30 years, in federal prison on each count, and a potential life term of supervised release. The indictment also notifies Johnson that the United States intends to forfeit his electronic devices which are alleged to have been used to commit these offenses.

Previously Convicted Sex Offender Sentenced to 130 Months in Federal Prison for Possession of Child Pornography

03/24/2022 12:00 AM EDT U.S. District Judge Ellen L. Hollander sentenced Roy Edward Gibbs, age 66, of Frederick, Maryland to 130 months in federal prison, followed by 25 years of supervised release, for possession of child pornography. Judge Hollander also ordered that, upon his release from prison, Gibbs must continue to register as a sex offender in the places where he resides, where he is an employee, and where he is a student, under the Sex Offender Registration and Notification Act (SORNA).

Vinita Man Convicted for Attempting to Sexually Entice a Minor

03/25/2022 12:00 AM EDT TULSA, Okla. – A Vinita man was convicted in federal court for attempting to sexually entice an individual he believed to be a 14-year-old boy. “John Flechs attempted to groom a child for sexual abuse via social media, but instead, was messaging an undercover officer with the Rogers County Sheriff’s Office,” said U.S. Attorney Clint Johnson. “Law Enforcement’s online undercover work is vital to unmasking predators who may have already reached out to a child or plan to do so in the future. Because of his conduct, Flechs was convicted of attempted coercion and enticement of a minor.”

Manchester Man Sentenced to 45 Years in Prison for Sex Trafficking

Offenses *03/24/2022 12:00 AM EDT* DES MOINES, IA – On March 23, 2022, Darrius Decnan Redd, age 33, of Manchester, was sentenced in federal court to 45 years in prison for sex trafficking an adult victim by force, fraud, and coercion; five years for facilitation of prostitution; and 40 years for distribution of a controlled substance to a person under the age of 21. The sentences are to run

concurrently (i.e., at the same time). A jury unanimously convicted Redd of those crimes in September 2021.
