# White House Releases National Plan to End Gender-Based Violence

The White House has released the first-ever “U.S. National Plan to End Gender-Based Violence: Strategies for Action.” The plan is a comprehensive, government-wide approach to prevent and address sexual violence, intimate partner violence, stalking, and other forms of gender-based violence.

The report discusses several OJJDP programs, including the National Resource Center for Justice-Involved LGBTQ+ and Two-Spirit Youth, Strategies To Support Children Exposed to Violence, and Reducing Risk for Girls in the Juvenile Justice System.
